Description

Bond It GRAFFITI REMOVER is a safe, non-toxic and low odour. Its concentrated formula penetrates quickly into graffiti, it can be safely removed by rinsing in soapy water.

Uses

Effective removal of ink, permanent marker pen and most spray aerosol paints from a variety of substrates including concrete, metal, glass, brick, stone and some painted surfaces.

THIS PRODUCT IS NOT SUITABLE FOR USE ON PLASTICS. Some marker pen and spray paints can be removed from plastic surfaces using Clean-It **MULTI-PURPOSE SURFACE WIPES**.

Preparation

ALWAYS TEST COATED / PAINTED SURFACES FOR COMPATABILITY PRIOR TO APPLICATION. It is the users' responsibility to determine suitability. STIR OR SHAKE WELL BEFORE USE.

Note: as all surfaces differ; it is recommended that this product is tested on a small inconspicuous area to determine suitability before use.

Application Procedure

Apply the **GRAFFITI REMOVER** directly to the problem area either by a brush, roller, cloth or spray direct on to the surface. Leave to soften for a few minutes, then use a brush or cloth to work it in the graffiti (leave longer and or apply a second coat of **GRAFFITI REMOVER** if the graffiti is slow to solubilise.) Once the graffiti has solubilised wipe off with a cloth/ paper towel. Apply a little **GRAFFITI REMOVER** to a clean cloth/ paper towel to wipe any remaining smears off the surface. Always wash down the treated surface with soapy water to remove any residues. Alternatively surfaces may be jet washed to remove residual material.

On brick and porous materials a longer soaking time may be required. Jet washing is recommended to help remove the last remnants of paint from the

surface. It may be necessary to repeat the process for thick or stubborn graffiti. Some small residual colour staining can be expected on porous surface.

Safety Advice

This product is non-toxic and safe for use in normal conditions. However, it is good working practice when handling any chemical product to wear protective gloves and glasses. The dissolved graffiti may contain irritants.

Health & Safety

Avoid contact with eyes and skin. If contact occurs; rinse with plenty of cold water. If symptoms persist get medical attention. Ensure adequate ventilation of the working area.
