## Concentrated Water Resistant Plasticiser For Water and Render

### Description

*A premium grade, concentrated integral water resistant plasticiser designed to improve resistance to water penetration both internally and externally whilst giving all the benefits of a mortar plasticiser.*

### Bond It POWER-PROOF

- ◆ Improves the plasticity of the mix making it easier to use.
- ◆ Retards suction in multi-layer renders.
- ◆ Reacts with free lime in the mortar to form hydrophobic crystals which block the pores, thereby improving the water resistance of the mix.
- ◆ Conforms to EN934-3:2009.

### Uses

To help mortars and renders resist external and/or internal water pressures. Suitable for use on renderings, retaining walls, swimming pools, roof screeds, basement walls and all applications where water penetration is a problem.

### Application

This product is supplied in a carefully measured dosage bottle, simply squeeze the bottle to administer the correct amount of liquid into the delivery nozzle.

Add to gauging water in the ratio of 25-50ml Bond It **POWER-PROOF** to each 25Kg bag of cement and reduce the total volume of gauging water to achieve the desired consistency. Use the appropriate sand/cement ratio for dense high quality mortar. Ensure the mortar is firmly compacted and do not over mix the mortar.

### Limitations

This is not a vapour-proofing product, therefore, a separate vapour-proof membrane is required for vapour-proof applications. Do not overmix the mortar/concrete, to prevent excessive air entrainment and subsequent loss of strength.

### Storage Conditions

Store in cool, dry conditions. Protect from frost.

### Shelf Life

Up to 24 months when stored according to manufacturers instructions.

### Coverage

25-50ml **POWER-PROOF** for every 25Kgs of cement.

### Disposal of Containers

Do not leave empty containers where residue could be harmful to children, animals or the environment. Replace lids and remove any containers to a central disposal point in accordance with local regulations.

### Health & Safety


- ◆ Avoid eye contact, wear eye and face protection. In the event of contact irrigate eyes immediately with plenty of cold, clean water for 15 minutes and seek medical attention.
- ◆ Avoid prolonged contact with skin. Wear wellington boots, protective clothing and gloves.
